We would like to inform you with this letter that Festo's products are largely affected by the EU sanctions against Russia and in particular are subject to Art. 2a and Annex VII as well as Art. 3k and Annex XXIII of Regulation (EU) No 833/2014, Art. 2a Annex VII of Regulation (EU) No 328/2022, Art. 3k Annex XXIII of Regulation (EU) No 576/2022 and are thus prohibited for sale, supply, transfer or export to Russia or for use in Russia. Same applies to Belarus according to Regulation (EG) No 765/2006.

Not only Festo but also any other company is subject to the aforementioned sanctions insofar as the sale of Festo Products is concerned. This letter shall prevent you and your company from violating the aforementioned sanctions and thus exposing yourself to significant legal consequences. Therefore, please make sure that no Festo products are delivered from you to Russia, Belarus or the territories occupied by Russia.

We would like to emphasize at this point that not only direct delivery to Russia/Belarus, but also delivery via third countries, in particular via so-called non-EU countries such as the Republic of Armenia, the Republic of Kazakhstan and the Kyrgyz Republic is prohibited. Such a delivery can be considered as circumvention of the existing sanctions and is also subject to sanctions to the same extent.

Please also inform your customers about the far-reaching sanctions existing for Festo products. You are welcome to use this letter for this purpose.

Please also note that Festo will not accept any liability for any consequences if you or your company does not comply with the aforementioned sanctions.
