on 1<sup>st</sup> of January 2023, the Act on Corporate Due Diligence in Supply Chains (LkSG) came into force in Germany. Festo SE & Co. KG as the parent company and the legally affiliated companies (the "Festo Group" with Didactic SE and Vertriebs GmbH & Co.KG, among others) are subject to the due diligence obligations defined in this Act (§ 3 para. 1 LkSG).

Our policy statement contains Festo's commitment to human and employee rights and our applied processes. We continuously document the defined measures for the protection of human rights on our website under Corporate Responsibility and in summary form in our annual sustainability report.

In addition, we have decided to have the performance of Festo SE & Co.KG's sustainability efforts evaluated by independent third parties on sustainability rating platforms. 
